Description of First Aid Measures

Eye Contact:

Immediately flush eyes with copious amounts of water. Remove any contact lenses. Rinse for at least 10 minutes. Get medical attention. Chemical burns must be treated promptly by a physician.

Inhalation:

Remove victim to fresh air and maintain in a rest position comfortable for breathing. If fumes are still present, all rescuers should wear appropriate respirators.
