## Section 4: First-Aid Measures

**Description of First Aid Measures**

**Eye Contact:**

Immediately flush eyes with copious amounts of water. Remove any contact lenses.

**Inhalation:** Rinse for at least 10 minutes. Get medical attention. Chemical burns must be treated promptly by a physician. Remove victim to fresh air and maintain in a rest position comfortable for breathing. If fumes are still present, all rescuers should wear appropriate respirators. If victim exhibits irregular breathing, trained personnel should provide artificial respiration or oxygen. Mouth-to-mouth resuscitation may be dangerous. ## Section 10: Stability and Reactivity

No significant exposure to titanium dioxide is anticipated while using this product, in which titanium dioxide is bound to other materials including resin and other pigments, during brush or rolling application.
