Section 4: First-Aid Measures

Description of First Aid Measures

Eye Contact:

Immediately flush eyes with copious amounts of water. Remove any contact lenses. Rinse for at least 10 minutes. Get medical attention. Chemical burns must be treated promptly by a physician.

Inhalation:

Remove victim to fresh air and maintain in a rest position comfortable for breathing. If fumes are still present, all rescuers should wear appropriate respirators. If victim exhibits irregular breathing, trained personnel should provide artificial respiration or oxygen. Mouth-to-mouth resuscitation may be dangerous. If necessary, contact a poison control center or physician immediately. If victim is unconscious, place in a

recovery position and seek medical help immediately. Maintain an open airway for the victim.

Skin Contact: Wash affected areas with soap and water. Remove contaminated clothing and shoes. Continue to rinse the affected area for at least ten minutes. Get medical attention if discomfort continues. Avoid further exposure in the event of any symptoms or complaints.

Extinguishing Media

Section 10: Stability and Reactivity

Effects of Over-Exposure

No significant exposure to titanium dioxide is anticipated while using this product, in which titanium dioxide is bound to other materials including resin and other pigments, during brush or rolling application.
