Section 4: First-Aid Measures

Description of First Aid Measures

Eye Contact:	Immediately flush eyes with copious amounts of water. Remove any contact lenses. Rinse for at least 10 minutes. Get medical attention. Chemical burns must be treated promptly by a physician.
